

## **Memorandum of Understanding**

This MOU has been signed among the following parties

**Government College for Women, Gurawara**

**And**

**ETASHA Society, A Non-Governmental Organisation**

Whereas **ETASHA Society** is a renowned name working for the upliftment of underprivileged women, adolescents, and marginalized communities developing the mindsets, attitudes, and skills needed for gainful employment and income generation, which in turn fosters self-respect, dignity, and social harmony.

Whereas **Government College for Women, Gurawara** is interested to collaborate with **ETASHA Society** to organize and carry out various activities for the benefit the girl's students of this college.

Now, Therefore, Parties agree as follows

1. **Purpose and scope of the MOU:** this MOU outline the terms and conditions for partnering among ETASHA Society and Government college for Women, Gurawara for organising various activities for all round development of the students enrolled in this college. The parties shall collaborate to identify and carry out activities that will be beneficial to the students in the area of technical education, entrepreneurship, personality development and society building.
2. **Activities:** the parties agrees to work together to organise and conduct various activities including but not limited to technical education, entrepreneurship, personality development, skill development awareness lectures on various social issues and other community development works. The specific activities to be carried out under this MOU shall be identifies and agreed upon by the parties on case to case basis.
3. **Responsibilities:** ETASHA society will be responsible for organising and conducting activities in collaboration with the college. The college shall provide support to the ETASHA society for organising the activities and shall encourage the students and faculties to participate in the same

4. **Funding:** ETASHA Society will bear the expenses for organising the activities including but not limited to the cost of technical education, entrepreneurship, personality development, skill development, awareness lectures on various social issues and other community development works.
5. **Validity:** This MOU shall be valid for a period of one year commencing from the date of signing of this MOU and may be extended by the mutual consent of both the parties.
6. **Termination:** Either party may terminate this MOU by giving 20 days prior written notice to the other party.
7. **Confidentiality:** the parties shall maintain the confidentialities of the information exchanged under this MOU and will not disclose to any third party without prior written consent of the other party.
8. **Governing law:** this MOU shall be governed by and construed in accordance with the laws of the state of India.
9. **Liability:** the parties shall not be liable to each other or to any third party for any indirect, incidental, consequential and punitive damages arising out of or in connection with this MOU except in cases of wilful misconduct or gross negligence.
10. **Signature:** this MOU may be executed in counterparts, each of which shall be deemed an original and all of which together shall constitute one and the same instrument.
